#### **11.11 Welcoming minute**

We welcome one another to YFGM in Bristol. We look forward to spending time together over the bank holiday weekend.

#### **11.12 Change in nominations structure**

We have heard from Erica Smith, our convener of nominations, about the changes proposed to how appointments to nominations committee could work - currently the nomination is for two years and

can lead to a feeling of isolation from the wider community as so much time is spent apart from the group.

Recognising this, and recognising the value of nominations committee getting to know the people in YFGM to strengthen our nominations procedure, we adopt the suggestion that people are nominated to nominations for three years, during which time they have six weekends on nominations and three weekends participating fully in the activities of YFGM.

This means that we will need a total committee of nine, of which six will be operating at any one time. The convenorship will be a one year commitment within the three years.

We ask the convenor to work out the further details of the rota system in the hope that it will be flexible.

We will pay travel expenses for people throughout the three years. (Any amendments to finance policy can be done further to this minute and put before the meeting later this weekend).

We encourage nominations to explore how they could do more of their work outside of YFGM weekends.

We will review this procedure at YFGM in May 2012.

#### **11.13** Symon Hill's walk of repentance for homophobia

Sam Barnett-Cormack has told us of former young Friend Symon Hill, who will be walking from Birmingham to London as a pilgrimage of repentance for his former homophobic attitudes and behaviours.

Sexuality and spirituality are issues which YFGM have explored and supported over the years. We are very proud that Symon is doing this action, and we are honoured to add our official support to his walk.

#### **11.14** YFGM enquirer's gathering, Feb 2012

Bryony Elias and Hannah Spires have suggested that we make YFGM in February next year free for newcomers, capping travel costs at £100 per person and waiving the expectation that they will make a donation towards the weekend's expenses.

We support this idea and hope that this will be a successful form of outreach. We ask all YFGM committees to consider the effect of increased turnout on their ability to fulfil their roles, and hope that they will consider how to deal with this issue. We will make this offer available only to those people who have registered two weeks before YFGM.

We will review this proposal in May 2012 with a view to making it a regular occurrence.

#### **11.15** YFGM accounts 2010

We have been part of a FWCC consultation for global change and have been working with Michael Eccles of Woodbrooke Quaker Study Centre to explore how young Quakers can be more involved with their work. Our appeal group have lead us in an interactive session, showing us how our work with Firefly is helping young people in war-damaged Bosnia.

We have also been looking inwards, in a spirituality session with Clive Dove Dixon, looking at what happens when we pray, and through a session celebrating 350 years of our peace testimony and how we can understand George Fox's words today.

In 2011, YFGM is 100 years old. This YFGM we have been thinking about our future - what we want to be doing over the next three years and what we think YFGM is and should be for. We look forward to producing a strategic plan for ourselves over the summer.

At February YFGM, we struggled with a difficult meeting house and a large and fluid community. It has been exciting to watch these disparate threads come together here over the long weekend, as friendships were formed and new connections made. We shared special interest groups in sign language, games, Jesus and non-violence, the living witness project, disability, government and media, labour behind the label, Woodbrooke young leadership development programme, improvised theatre, vegan organic chocolate-making, art and anger, journaling, a trip to Vegfest, tango, new ideas for the website, YFGM's strategic plan, and what happens when you pray? We have enjoyed creating music, food and art, sang songs and made plays in our cabaret and worshipped together in candlelit epilogues.

This YFGM we say goodbye to Siobhan Haire, our co-clerk. We would like to thank Siobhan for her warmth, her cheerfulness and humour and her practical good sense. Siobhan has given so much time and dedication to YFGM in her period as trustee. We hope that she will continue to eat cheese with us, play the animal game and correct us when we're about to break the law.

Many of us are leaving YFGM and travelling to new places and new opportunities. We value the support that we have received here and hope that we can take the light that YFGM has given us and carry it out with us into the world.
